Single rooms are available at a supplementary cost. **TIPPING:** Minimum tips for guides and drivers are regulated by the State of Israel and will be added to the price of all tours. Tips will be pre-collected with tour invoicing. **INSURANCE:** Optional insurance policy available, please see our website or contact ITC TOURS for details. **MEDICAL CONDITION:** ITC is not responsible for any medical conditions that may occur during or prior to the tour. **CANCELLATION:** All cancellations must be in writing to us and must be signed by the person who made the original reservation. Cancellations are only effective from the day they are received by us. No refunds are issued for cancellations received after the date the tour departs. If you cancel the land or air portion of the tour, cancellation fees and penalties may be deducted from your refund or deposit. Cancellation fees apply to each person. Penalty fees apply on returned checks.
