## TERMS AND CONDITIONS

**ROOMS:** Prices are based on double occupancy. Single rooms are available at a supplementary cost.



**TAXES:** Airport tax and fuel surcharge are included in the ticket price when ticketed.

**INSURANCE:** Insurance is not included in the tour price. We strongly recommend that you purchase travel insurance. Please note that we cannot accept responsibility for any losses or expenses, which you or any member of your party may incur as a result of failing to secure adequate coverage.

**MEDICAL CONDITION:** ITC is not responsible for any medical conditions that may occur during or prior to the tour.

**CANCELLATION:** All cancellations must be in writing to ITC Tours, and must be signed by the person who made the original reservation. Cancellations are only effective from the day they are received by ITC Tours. No refunds are issued for cancellations received after the date the tour departs. Penalties will apply. If you cancel your tour, cancellation fees and penalties will be deducted from your refund or deposit. Cancellation fees will apply to all deposit checks.
