VISA INFORMATION*: All travelers must have a valid passport and a Cuban visa. You are responsible for having proper documentation on your person to enter Cuba as well as to re-enter the United States and proper documentation to travel via a third country (if necessary) to Cuba. For certain categories of travel Marazul can assist with the Cuban visa application. The Cuban Government retains the right to grant or deny visas.

*Very Important: persons born in Cuba, no matter what your current citizenship, will require additional documentation.

U.S. AUTHORIZATION TO TRAVEL: Marazul can only make arrangements on behalf of individuals authorized to travel by the Office of Foreign Assets Control of the U.S. Department of the Treasury under a General License or Specific License.

ITC Tours and Marazul accepts no responsibility for the issuance or denial of licenses by the Office of Foreign Assets Control nor for the issuance or denial of visas by Cuba.

31 C.F.R. § 515.565(b) People to People Travel

Organizations participating in educational exchanges not involving academic study pursuant to a degree; <u>provided</u> that:

- i. Travel must be for purposes of engaging in a full-time schedule of activities intended to enhance contact with the Cuban people, support civil society in Cuba, or promote the Cuban people's independence from the Cuban authorities;
- ii. Each traveler must have a full-time schedule of educational activities that will result in meaningful interaction with the Cuban people;
- iii. The predominant portion of the activities cannot be with or on behalf of individuals or entities acting for Prohibited Government Officials or Prohibited Communist Party members (as defined in the CACR);
- iv. Travel must be conducted under the auspices of an organization that sponsors exchanges to promote people-to-people contacts, and an employee, paid consultant or agent of the sponsoring organization must travel with each group to ensure that each traveler has a full-time schedule of educational activities;
- v. The organization and the travelers must maintain records for 5 years, sufficient to demonstrate that each traveler has engaged in a full-time schedule of activities that satisfy requirements (i) through (iii).
